New Business: By Laws Change for Associate Members: Wendy Johnston wrote an amendment to our by Laws for Associate Members that was approved by the Board of Directors. The amendment reads:

Monterey Bay Hunting Retriever Club, Inc.

Proposed Bylaws Amendment – April 14, 2012

Amend Article 3. Members, Section 1 as follows:

The Corporation shall have <u>two classes</u> of members, <u>Regular and Associate</u>. No member shall hold more than one membership in the corporation. Except as expressly provided in or authorized by the Articles of Incorporation or Bylaws of this Corporation, all memberships shall have the same rights, privileges, restrictions and conditions <u>except that Associate Members may not vote or hold office in the corporation</u>. The corporation can give members a proprietary (ownership) interest in the corporation and upon dissolution and after paying the debts and liabilities of the corporation, can distribute the remaining assets, gains, profits, etc., to <u>Regular members</u>.

Amend Article 4 Meetings of Members, Section 7 Voting Rights:

Each <u>Regular</u> member is entitled to one vote on each matter submitted to a vote by the members. Voting at duly held meetings shall be by voice vote. Election of Directors, however, shall be by ballot.

A motion was made and seconded to approve the amended by-laws.

John Culin Memorial Super Singles: It was agreed to hold the Super Singles on Sunday, August 12 at Jones Lake. Debbie Tandoc has agreed to Chair the event. Debbie requested suggestions for judges. John Culin Jr. is providing monies for the Hot Dog BBQ and therefore a chef is needed to do the BBQ (hot dogs, buns, condiments and water) as last year's chefs will be out of town.

The next MBHRC Meeting will be held on Sunday, July 29, 2012 at Jones Lake.
