## **Hunt Test Summary Reports**

Each year we do a great job and our test runs smoothly according to Wendy, Hunt Test chair. We had challenge with the junior/senior judges and the Master B judging pair was not ideal. The club tries to give new judges a chance to participate. Bird boys were great. Gunners were good. Patty Polish was awesome as well as her friend Sue. The club acknowledges Chris Hempel for helping at Master B and extends a special thanks to Pat DeNardo for all her valuable contributions as our Master B stake marshall. And, a big thank you to Ray Kaufman for throwing birds and teaching the bird boys good techniques. Kate Davern's boyfriend was a great help too. Thanks to Pam and Phil Durkee for selling raffle tickets. Hats off to David and Katya Rant for going above and beyond helping our club by bringing the much needed tables for the BBQ and raffle despite unforeseen health challenges. A big thank you.

The food was good – thank you Luane. We could not have done any better. 65 dinners were ordered for the BBQ and based on plate count, 75 were served. It was good to have at least 3 servers plus money/ticket collectors (Thanks Steve and Jeannie).

Per Lucy, the gun raffle pulled in \$3342 with an outstanding expense due for the 28gauge (~\$500). And the winger raffle pulled in \$150.00. The bird boy expense was less than expected at \$1900.00 Plus the bird boys



received tips from the tip jar. The club sold remaining live birds to Katie Quarels, bringing in \$195.00 and Anne Pletcher conducted an auction for the remaining dead birds brining in another \$60.00! The Quality Inn messed up the judge's hotel bill. Anne is working with the hotel to straighten out the issues. Lucy is waiting for the final hotel bill cost and Don's travel expense. Based on preliminary calculations the raffle netted about \$1,000.00 less than last year. We need to more clearly promote the fact Lucy can accept credit card purchases. Lucy was busy serving food.

Club members were easy to identify at the test by their MBHRC sweatshirts!

Debbie Fulgoni submitted a report prior to the meeting. We have 1 case plus 3 boxes of 6 and 7 steel shot. Plus we have 2 cases and 5 boxes of poppers. Lucy reported she also has a case of poppers at home that we can use next year.

#### Tips for 2016:

It was recommended we order more birds next year to ensure we have enough. Katie typically purchases our remaining live fliers which will minimize any expense loss.

Next year the club would like to have the Los Baños Trap Shooting club back again to help. The tip jars will be more clearly announced in advance.

Rich will be in charge of ordering ammo for the Single Series (if held at Denverton with live fliers) and next year's Hunt Test. (Able Ammo, Max or Roger's)

Judges. Commitments received for 2016 include, Kimberly and Chris Dotson, Joe Reinhardt and Denise is checking on one other. Members indicated the Ferners would be nice to have at our test.

### **New Business:**

The club approved a new associate member, Claire Caro. She is a GRC board members and well-known in the sport.

**CRTA Policy**: Lucy paid our one-time \$200.00 fee enabling our club to host events at Denverton and Grizzly Island. Lucy received the paperwork containing rules and requirements.

High interest was expressed to hold our annual Single Series at Denverton. Denise will reach out to Debbie Tandoc to learn about upcoming events. Lucy will contact Xian to start to map out dates. Anne Pletcher previously committed to chairing the event. Sage Hens had a similar event that was well run. Those who signed up were also assigned a task to do at the event. For their event, club members were free and guests paid \$15.00 for one flier. There is a big advantage for participants in our event at Denverton — they are not required to pay the \$35.00 daily use fee.



The club is also interested in holding a club meeting and training day at a future time at Denverton.
