HT Secretary Report: Hunt Test applications are now processed out of the Fresno office. Anne submitted our application a few weeks ago and the Fresno office is not responding. Loni from the Wildlife office in Los Baños offered to assist. Anne will continue to follow-up. Our club is required to pay an additional \$300-\$400 for use of the Los Baños Wildlife Refuge area in 2016 plus submit a rather lengthy application to the state. Anne and Wendy do not foresee any issues.

**Raffle:** Thanks to Hamilton's connections, in addition to the Winger Zinger Wendy will purchase for the raffle, Hamilton gained confirmation from Garmin for the donation of a Sports Pro 500 collar. One hundred Garmin goodie bags are also being sent to the

**Master National:** Wendy shared that the amendment to the Master National Bylaws to relax the requirements of judge qualifications to reflect a Master National judges need not have participated in a Master National hunt test, failed. The nominated judges from our area named include Laura Judd, Ron Margiotta and Jim Charboneau. It required 2/3 approval. Held in South Carolina, the recent Master National was the largest AKC event ever with 932 dogs. About 270, or one-third passed.
