Meeting brought to order at 9:20a.

The secretary's report was accepted as viewed on Line.

Lee Wyker was unable to attend (our treasurer) due to her car breaking down. Therefore, Nancy Kelly, advised we have \$11,550.58 in the treasury.

Since we have lost the use of Jones Lake, we need to find alternate locations to field train. One suggestion is Ogier Road which is in San Jose. Jamie Warren graciously checked it out for us. The fields are not ideal but there is useable water on the property. I have attached an application to San Jose Retriever Club which is necessary to gain mobile access to the grounds.

The members present voted to increase our membership at Denverton so MBHRC has access to monthly training and meeting space for an additional fee of \$350. NJK will contact Alice @ CRTA to make this happen.

The Singles Series has been cancelled due to the loss of Jones Lake; however, we might hold it at Denverton if we can get support of the MBHRC membership. Currently it is on hold.

After much discussion it was decided we would not hold a 2023 Hunt Test, as we do not have enough membership who are able to organize and work the test. Instead, we are considering holding a NAHRA (North American Hunting Retriever Association) Seminar (inviting outside members) with the possibility of holding a NAHRA test in the future and as a fund raiser. It would be held over the weekend we usually reserve for our Hunt Test. Alan Kabert is checking into confirming a representative from NAHRA for that weekend Feb 18-19, 2023.

The MBHRC trailer and the boat are located at Alan's house in Gilroy. The trailer had to be moved from Sundowner Kennel, since the property is being sold. The boat and everything in the Jones Lake shed had to be moved since we lost the lease to the property

We were unable to confirm the next meeting as it is contingent on when we can book Denverton. Membership will be notified by MBHRC group list when I have additional information.
